- 12 (a) The Tender schedules will be issued up to 23.07.2015 up to 5.00 PM. The supply of Tender schedules by post will be at the risk and responsibility of the contractor/Agency.
(b) Last date & time for submission of filled tender schedules along with necessary document copies is on dt.25.07.2015 @ 03.00P.M and will be opened on the same date @ 03.30 P.M.
- 13 The cost of tender schedules will not be refunded under any circumstances. The E.M.D shall be refunded to the unsuccessful tenderer soon after deciding the tenders.
- 14 The application for tender schedules received late will summarily be rejected.
- 15 The tenderer must keep his tender valid for a period of 90 days. If the tenderer withdraws his offer within the validity period the E.M.D will be forfeited.
- 16 The contractor shall not, without the written consent of the General Manager (Engg), concerned assign the contract or sublet any portion of the same to any other person.
- 17 Tenderer should quote their percentage both in words as well as in figures, the percentage quoted in words shall prevail. If the contractor fails to quote his percentage both in figures or words the tender will be treated as incomplete and rejected.
