1.0 Introduction:

The O&M Division No - XVIII is a newly formed division having jurisdictional limits covering areas viz Manikonda, Puppalguda, Narsingi, Nekkampur , Bachupally villages etc. Earlier the drinking water supply to these villages is provided by the RWS Department by giving bulk supplies through Grampanchayaths, Rural Habitations, municipalities and Municipal corporations both inside and Outside ORR as per norms.

The Government of Telangana vide G.O.RT.No:274 dt: 30.04.2015 has ordered that the RWS&S Department through TDWSC shall provide bulk drinking water supply to all the GPs, Rural Habitations, Municipalities and Municipal corporations Outside ORR as per norms. The Drinking water supply for all the GPs, habitations, colonies, institutions and other urban areas etc within ORR shall be provided by the MA&UD dept through HMWSSB.

As per the above, it was frequently requested by the residents of Bachupally Grampanchayath of Quthbullapur mandal to the HMWSSB Dept for providing water drinking water supply by HMWSSB it is proposed to take up a technical feasibility survey for designing network for laying main water supply pipelines including distribution pipelines, preparation of estimates, plans with contour levels including drawings covering entire area of Bachupally Grampanchayath under Nizampet section.

I.SCOPE OF WORK

2.0 The scope of the services to be provided under this contract are:

HMWSSB is looking for consultancy services for the preparation of Conducting of detailed survey, design of water supply of main pipeline and distribution pipelines, estimates, plans with contour levels, making drawings of above all of the areas under Bachupally Grampanchayath. The consultancy should execute conceptual planning and design aspects taking cognizance of the present and future requirements of the said selected areas.

Some of the areas where the consultancy has to undertake studies and submit reports are

- i. To study the areas and propose various alternate alignments for laying the transmission and distribution mains and suggesting the best alternative with its advantages which suits the site requirement.
- ii. To study and propose the required transmission and distribution main for clear water with suitable size & material including alignment.
- iii. To study the existing Water Supply system at Bachupally Grampanchayath area and provide the details of the projected demand in the future of that area for the year 2040.
- iv. The detailed project report should consist of the methodology adopted for justifying the final proposal including the cost estimates etc.
- v. To furnish detailed hydraulic designs, layout plans, survey drawings, L-sections, cost estimates with back up quantities, rate analysis supported with quotations etc., complete for all the proposed components such as Transmission Mains, Distribution mains etc.
- vi. The scope of additional revenue generation and operational improvements etc.,
