#### **ORDER:**

In the reference read above, the Managing Director, Hyderabad Metropolitan Water Supply & Sewerage Board, Hyderabad has stated that the Board was constituted by enactment of HMWSSB Act, 15 of 1989 and Section 22 of the HMWSSB Act, the consumers are required to pay the water bill amount for water supplied. The Managing Director, Hyderabad Metropolitan Water Supply & Sewerage Board, Hyderabad has stated that an amount of Rs.457.75 Crores dues including interest of **Rs. 158.18** Cores is to be recovered from the consumers of Slum dwellers, Rajiv Gruha Kalpa (RGK) and Domestic category as on 30.11.2015. The category wise details are as shown below:

- 2. The Managing Director, Hyderabad Metropolitan Water Supply & Sewerage Board has stated that, despite issue of notices and constant persuasion with the consumers by enforcing the provisions of Revenue Recovery Act, regarding arrears the response from the consumer of above categories is very meager. During the review meeting on HMWS&SB issues, the Government has directed the Board to consider for waiving of total outstanding dues as on 30.11.2015 amounting to **Rs.457.75** Crores which includes principal amount of **Rs.299.52** Crores and interest of **Rs.158.18** Crores in respect of consumers of Slum dwellers, Rajiv Gruha Kalpa (RGK) and Domestic category. Accordingly the Managing Director, Hyderabad Metropolitan Water Supply & Sewerage Board, Hyderabad has submitted the proposal to the Government for consideration and issue of orders waiving the total outstanding dues as on 30.11.2015.
- 3. Government after careful examination of the matter, hereby decided to waive the total outstanding dues as on 30.11.2015 amounting to **Rs. 457.75** Crores which includes principal amount of **Rs.299.52** Crores and interest of **Rs.158.18** Crores in respect of consumers of Slum dwellers, Rajiv Gruha Kalpa (RGK) and Domestic category, subject to that consumer must be prompt in payment of monthly bills henceforth.
- 4. Accordingly, Government hereby waive total outstanding dues as on 30.11.2015 amounting to **Rs. 457.75** Crores which includes principal amount of **Rs.299.52** Crores and interest of **Rs.158.18** Crores in respect of consumers of Slum dwellers, Rajiv Gruha Kalpa (RGK) and Domestic category, subject to that consumer must be prompt in payment of monthly bills henceforth.

- 5. The Managing Director, Hyderabad Metropolitan Water Supply & Sewerage Board, Hyderabad shall take necessary action accordingly.
- 6. This order issues with the concurrence of the Special Chief Secretary (Finance).
