## ORDER:-

In the letter first read above, the Managing Director, Hyderabad Metropolitan Water Supply and Sewerage Board, Hyderabad has reported that the Government has accorded administrative sanction to the project costing to Rs.3375 Crores duly indicating the source of funding vide G.O.Ms.No.679, Municipal Administration and Urban Development (W1) Department, dated 26.09.2008 and the project works are let vide G.O.Ms.No.693, 694 and 695, Municipal Administration and Urban Development (W1) Department, dated 01.10.2008. Agreements concluded and the works have been grounded. The manufacturing of pipes is completed for about 28 Kms. and further manufacturing of pipes including land acquisition and other associated items of work are in progress. As per the contractual obligation, so far an amount of Rs.242.35 Crores is released in all the 3 packages including part payment of Rs.10 Crores towards Land Acquisition.

- 2. The Managing Director, Hyderabad Metropolitan Water Supply and Sewerage Board, Hyderabad has further reported that apart from the due payments for the work done to a tune of Rs.146.83 Crores, further bills are under process for pipes under manufacture and compensation towards land acquisition of Rs.191.60 Crores. Thus a total amount of Rs.338.43 Crores is required for immediate payment towards committed expenditure on the project. As per the funding pattern vide G.O.Ms.No.679, Municipal Administration and Urban Development (W1) Department, dated 26.09.2008, the Government of Andhra Pradesh share amount for the year 2009-10 is Rs.501.60 Crores and is yet to be released by the Government for the project.
- 3. The Managing Director, Hyderabad Metropolitan Water Supply and Sewerage Board, Hyderabad has, therefore, requested the Government for release of funds at least to the extent of Rs.125 Crores out of Government of Andhra Pradesh share amount towards  $\mathbf{1}^{\text{st}}$  and  $\mathbf{2}^{\text{nd}}$  quarter budget as per the budget provision made for the year 2009-10 at the earliest to clear the pending bills and maintain the progress of the work.
- 4. In the G.O. second read above, Government in Finance (Expr.M&F) Department have issued Budget Release Order for an amount of Rs.6,250.00 lakhs as additional in relaxation of Treasury Control Orders.
- 5. Accordingly, Government hereby accord administrative sanction for an amount of Rs.62.50 Crores (Rupees sixty two crores and fifty lakhs only) towards the share amount of Government of Andhra Pradesh of  $\mathbf{1}^{\text{st}}$  quarter budget as per the budget provision made for the year 2009-10 to clear the pending bills and maintain the progress of the work.
