Introduction

The Hyderabad Metropolitan Water Supply and Sewerage Board (HMWS&SB), was constituted on 1.11.1989 under the provisions of Hyderabad Metropolitan Water Supply and Sewerage Act 1989 (Act No . 15 of 1989), with the following Functions & Responsibilities in the Hyderabad Metropolitan Area.(i)The Supply of potable water including planning, design, construction, maintenance, operation & management of water supply system.(ii)Sewerage, Sewerage Disposal and sewerage treatment works including planning, design, construction, maintenance, operation & management of all sewerage and sewerage treatment works.

Background

HMWSSB solicits the cooperation and participation of all citizens and started the common cause of implementation of a massive programme on Rainwater Harvesting / Conservation this year. The Board is offering applications from the interested Residential Welfare Associations for conducting Awareness programmes in the colonies for technical guidance to construct Rainwater Harvesting / Conservation Structures themselves in their own premises at their own cost. The Board also will take up construction of Rainwater Harvesting Structures along with injection wells in the open places, parks etc. in the colonies on the request of interested Residential Welfare Associations if they enter into MOU with the Board for regular maintenance of the structures to augment the depleted groundwater to mitigate water problem in Urban areas. The Assistant Director (GW), HMWSSB will conduct Awareness programmes in the respective colonies and select suitable areas for construction of suitable Rainwater Harvesting structures. A rain water harvesting theme park was being built at Jubilee Hills for creating awareness on water conservation among the city residents for awareness to public regarding Rain water harvesting.

Objective

In order to attract children for creating awareness on water conservation, the objective is for hiring services of a Professional Agency for Animation work including virtual reality work, Holographic projection, Interactive Games, Projection Mapping etc for the development of Rain Water Theme Park along with resource center at Road.No.51 Jubilee Hills.

Scope and Requirement

HMWSSB requires the services of an experienced and multidisciplinary animated E-learning content development agency with experience in the field of Animation work including virtual reality work ,Holographic projection, Interactive Games, Projection Mapping etc for the development of Rain Water Theme Park along with resource center at Road.No.51 Jubilee Hills . It envisages the following activities as part of the scope of work for HMWSSB.

The bidders are allowed to respond as individual entities or in the form of consortium for this opportunity. Only one bid will be allowed from a consortium. Potential respondents with the relevant technical experience should submit their responses as per the formats in Annexure B & C, along with the non-refundable fee, highlighting their capabilities to perform the following activities:

- ❖ 5 minute short film for RWH and water preservation: Chota Bheem themed 5 minute animated film. The film will focus on rain water harvesting, water cycle and water preservation. The film can be played in auditorium with non-exclusive rights.
- Virtual reality journey of water: A virtual reality experience how water reaches your home from Krishna/Godavari where user will be a water droplet going through the entire process of treatment and finally reaching home this experience can also be played in auditorium
- Holographic projection of Sewage treatment and water treatment plants: 3D models of sewage and water treatment plants will be created. These 3D models will be showcased in our holobox which is our holography technology kids can briefly interact with projection like changing from one plant to the other
- ❖ Interactive touch panel game: A casual game will be created on the theme like recycling waste water in your home. This game will be installed on touch screen panel where kids can jointly work together to achieve required results
- ❖ Musical fountain: A six pattern musical fountain will be installed in the park fountain. The fountain will work with RGB lights and will react to the beat of the music. Multiple shapes can be achieved etc
- ❖ Existing architecture / land scaped will be used to project 3D imageries. Projection mapping will have a story about water cycle to importance of saving water. Whatever objects will have projected map will come to life and will have sound and music to support. This will be of 3 minutes

Qualifying Criteria

- I. The Bidder should be a Registered Firm with Govt. of Telangana. Need to provide company registration certificate and proof of nature of work/nature of company
- II. The Bidder/ Lead Bidder of the Consortium shall possess strong technical capabilities in 3D Animation, and visual effects for providing creative and technical services for Media, Advertisement, Gaming, Internet and Entertainment related projects in any organization. Supporting documents for all projects to be provided as per the format specified in Annexure A, Section 4.
- III. The bidder shall be in the field of 3D Animation, and Visual effects based applications for a minimum of 5 years as on date of the Bid. Documentary proof of work order copies shall be submitted.
- IV. The bidder shall have completed at least 3 projects in the field of 3D Animation, and Visual effects based applications - projects for any organizations conducted 5 years previous to the date of the bid. Supporting to be provided as per the format specified in Annexure A, Section 4.
- V. The bidder shall have a minimum annual turnover of Rs. 3.00 Crores with positive net worth as on date of submission of bid for each of the last three audited financial years (FY 15-16, FY 16-17, FY 17-18) or less as the case maybe. Supporting to be provided as per the format specified in Annexure B, Sec 6 and Sec 7.
- VI. Agency should have its office or its subsidiary at Hyderabad at least for the last 3 years. Suitable documentary proof to be provided
- VII. In case of consortium, the Lead Bidder of the Consortium shall have prior experience of working in at least 1 project with the Consortium Member for implementation of activities for similar projects. Supporting to be provided as per the format specified in Annexure A, Section 4.
- VIII. The Bidder/ Lead Bidder of the Consortium shall have a multidisciplinary team of at least 10 professionals (minimum) in the field of 3D Animation, and visual effects Management System, audio video media, graphic designers, market researchers, and other relevant capabilities as part of Learning Management System and support having knowledge in local languages Telugu/Hindi is essential. Supporting to be provided as per the format specified in Annexure A, Section 5. The profile of the professionals should be submitted along with the bid
 - IX. The Agency is requested to file an undertaking on appropriate court fee stamps, stating therein that Annexure A, Section 6.

VII. The Bid should be accompanied with non-refundable tender fee of Rs. 5000/-(Rs Five Thousand only). The Bid without tender fee will not be entertained. An EMD of 1% of Rs. 70,300/- (Rs. Seventy Thousand and Three Hundred only) in the shape of Demand Draft drawn in favour of HMWSSB payable at Hyderabad to be attached with the bid. This amount will be converted as security deposit of the successful bidder.

Post selection of the agency, the agency should also provide a bank guarantee of balance 1 ½ % on the quoted value to HMWSSB for concluding agreement and for successful implementation of the project.

All bidders or Consortium with the above criteria will be eligible to submit financial bids.

Bid Selection Process

- i. All the bidders shall be assessed against the Qualifying criteria listed in the Bid invitation.
- ii. HMWSSB through this Bidding process intends to consider those potential bidders that have the requisite capability and competency, in terms of technical strengths, experience of carrying out similar projects and financial stability to address the requirements of HMWSSB
- iii. The financial bids of technically qualified bidders alone will be considered for evaluation. The financial quotes shall be as per the unit cost as given in the annexure.
- iv. HMWSSB's decision on evaluation shall be final and binding on all the bidders.

Bid Submission process

Interested firms/consultants must provide information indicating that they are qualified to perform the Services (Cover-A) (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc. with fee payable to HMWSSB) along with their financial offer.(Cover-B). Both covers A & B shall in turn be enclosed in One Single cover with Tender No. Name of the work and Name of the Consultant / Firm should be super scribed on the top of the cover. The Technical Offer (Cover-A) will be opened initially and assessed the capability of Consultant, Financial Offer (Cover-B) of the qualified tenders will be opened later duly informing the Agency. The tenderers must submit the tenders on due date & time in sealed cover as above and should be submitted to the Chief General Manager (E), Transmission Circle, Khairatabad, Hyderabad.

Instructions to the Bidders

- i. Bidders shall study all instructions, forms, terms, requirements and other information in the Bidding invitation documents carefully. Submission of the bid shall be deemed to have been done after careful study and examination of the Bidding invitation document with full understanding of its implications.
- ii. Language of Proposals The proposals, all correspondence and document enclosed as part of the proposals shall be in English language only.
- iii. Proposals received after the due date and the specified time for any reason whatsoever, shall not be entertained and will be rejected without opening.
- iv. HMWSSB shall, at its discretion, extend the deadline for submission of proposals by publishing the details on the website where the Bidding invitation document was made available.
- v. All costs incurred by the respondent in the preparation and presentation of the proposal shall be borne entirely by the respondent. All supporting document submitted by the respondent in response to this Bidding Invitation shall become the property of HMWSSB.
- vi. This Bidding does not constitute an offer by HMWSSB.
- vii. All proposals and accompanying documentation submitted against this Bid, once opened will become the property of HMWSSB and will not be returned.
- viii. The bidder shall not be permitted to sub-contract any of the core activities of the project except minor activities as permitted by HMWSSB.
