Preamble:

HMWSSB has taken up certain reforms in SWC and decentralized powers to sanction new connections to the field officers with an objective to make the system citizen friendly. The Board desires to ensure that all the new connections are sanctioned as per the standard procedures and road restoration are executed as per the guidelines issued to GB contractors in the service area of HMWSSB jurisdiction through (4) Four no's of Third Party Inspection teams.

Scope of work:

To Cross check the Plot area and Plinth area mentioned in the feasibility report by the Managers at site.

To Cross check the Height of the building (including pent house) and no. of floors mentioned in the feasibility report at site.

To Cross check the Category of the connection sanctioned at site.

To scrutinize the documents submitted by the applicants as per the norms prescribed.

To verify the improvement charges levied on the applicant.

To verify the amount mentioned in the Intimation Order issued, for its correctness.

To verify and certify the quality of road restoration.

All filed reports will have to be submitted within 2 days from the date of allotment.

To verify whether BPL connections sanctioned as per norms prescribed are not.

To verify the length of the road cuttings proposed in the feasibility report.

The consultant shall assist HMWSSB in obtaining funding for the implementation of the project from External funding agencies or any financial institutions in India.

The Consultant/ agency shall enter into agreement for 12(twelve) Months and/or extended from time to time on mutual agreement as per the requirement.
